The average purchase price paid on the stock market was GBP 33.863958. The company bought back shares for a total price of GBP 65,662.215 (excluding ancillary costs).

The acquisition of shares of RWE Aktiengesellschaft was exclusively executed in the stock market at Frankfurt Stock Exchange (XFRA).
