On January 8, 2018, the New York State Board on Electric Generation Siting and the Environment (Siting Board) issued a Notice of Availability of Application Stage Intervenor Funds and Schedule for Submitting Funding Requests (January 8 Notice), stating that \$300,000 in application stage intervenor funds were available for award to eligible municipal and local parties and establishing February 7, 2018, as the due date for submission of funding requests. On February 6, 2018, the Secretary of the Siting Board extended the due date for submission of funding requests to April 2, 2018.

please take NOTICE that, in addition to the \$300,000 of funds identified in the January 8 Notice, \$75,879.52 of funds remaining from the pre-application intervenor fund account also shall be made available to eligible municipal and local parties at this stage of the proceeding. Therefore, a total of \$375,879.52 of funds is available for use by eligible municipal and local parties in contributing to a complete record leading to an informed decision by the Siting Board as to the appropriateness of the site and facility and to defray expenses for expert witness, consultant, administrative or legal fees (other than in connection with judicial review). At least 50 percent of the funds must be reserved for potential awards to municipalities.

Requests for intervenor funds will be accepted until April 2, 2018. Requests for intervenor funds should be submitted to the Examiners, Administrative Law Judge James Costello (James.Costello@dps.ny.gov) of the Department of Public Service and Administrative Law Judge Maria E. Villa (Maria.Villa@dec.ny.gov) of the Department of Environmental Conservation by 4:30 p.m. on April 2, 2018. A copy of each request also must be filed with the Hon. Kathleen H. Burgess, Secretary of the Siting Board, at Secretary@dps.ny.gov by 4:30 p.m. on the due date. Persons without e-mail access may send their documents to the Examiners and Secretary Burgess by first class mail at the New York State Board on Electric Generation Siting and the Environment, Three Empire State Plaza, Albany, New York 12223, such that the requests are received by the due date.

Copies of requests also must be served on other persons identified on the party list for this proceeding, by email or first class mail.
