INFORMATION TEXT ON THE PROCESSING OF THE PERSONAL DATA OF VISITORS

I. Data Controller

In accordance with the Law No. 6698 on the Protection of Personal Data ("Law" or "LPPD"), your personal data may be processed by RWE & Turcas Güney Elektrik Üretim A.Ş. ("Company" or "RWE") as the data controller within the scope described below.

II. Methods of Collecting Personal Data and Legal Reasons thereof

Our company collects personal data directly from the visitors themselves, from the CCTV system located in buildings, facilities, campuses, workplaces, appurtenances, courtyards, entrance doors, building exterior façades, wire fences, office space entrances, event areas, visitor waiting rooms, parking lot, security cabins and floor corridors and other service areas, traffic/log records and other communication channels if the internet is accessible, from the data learned aurally, electronically or in writing. Your personal data is processed based on the legal reasons of it being explicitly stipulated in the laws (for example, processing of internet traffic records in accordance with Law No. 5651, processing of personal health data related to Covid-19 such as vaccination status within the scope of the fight against the epidemic for the purpose of protecting public health, public safety and public order), fulfillment of legal obligation (for example, monitoring compliance with occupational health / safety rules, prevention of unauthorized access to working areas in order to ensure information security), and the legitimate interest of the data controller (for example, keeping the camera records for the purpose of ensuring the security of the physical space).

IV. Purposes of Processing Personal Data

Your personal data is processed for the purposes of creation and follow-up of visitor records, ensuring physical area security, planning, auditing and implementation of information security processes, providing information to authorized persons, institutions and organizations, ensuring the security of the Company's campus and / or facilities, ensuring the legal, technical and commercial-business security of the Company and the relevant persons in business relations with the Company, creating and managing the information technology infrastructure, planning and ensuring that the visitors exercise their powers to access to information.

V. Transfer of Personal Data

Your personal data is processed in line with the realization of the above-mentioned purposes and limited to the fulfillment of such purposes and, in this context; <u>the following data</u> is shared <u>with the following parties/persons</u> both at home or abroad:

- the data such as identity information, camera records with the security company and the service provider establishing or operating the technical infrastructure with a view to ensuring the security of the company and its campuses;
- the related data with our group companies located abroad towards which we have the obligation to report the name/family name and title data within the scope of the management of emergency drills;
- the data such as visitor name/family name, institution of employment, entry-exit hours data with our group companies located abroad that provide, operate or serve our information infrastructure within the scope of hosting service; and
- log records and camera recordings with administrative authorities, judicial authorities or relevant law enforcement agencies in case of being demanded for resolving legal disputes or being required by the relevant legislation.

VI. Your Rights listed in Article 11 of the Law as a Personal Data Subject

As personal data subjects, you have the following rights:

- Learning whether your personal data is processed or not;
- If your personal data has been processed, requesting information about it;
- Learning the purpose of processing your personal data and whether they are used in accordance with their purpose;
- Knowing the third parties to whom your personal data is transferred domestically;
- If your personal data is processed incompletely or incorrectly, requesting their correction;
- Requesting the deletion or destruction of your personal data;
- In case your personal data is corrected, deleted or destroyed, requesting that these procedures be notified to the third parties to whom your personal data is transferred;
- Objecting to the occurrence of an outcome against you by analyzing your processed personal data exclusively by means of automated systems; and

- Requesting compensation if you suffer damage due to unlawful processing of your personal data.
